4. FIRST AID MEASURES

4.1 Description of first aid measures

Eve Hold eyelids apart and flush the eye continuously with water. Continue for at least 15 minutes

If inhaled, remove from contaminated area. To protect rescuer, use an Air-line respirator or Self Contained Inhalation

Breathing Apparatus (SCBA). Apply artificial respiration if not breathing. Give oxygen if breathing is difficult. Seek immediate medical attention. For advice, contact a Poison Information Centre on 13 11 26 (Australia

Wide) or a doctor.

Skin If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water.

Ingestion Due to product form and application, ingestion is considered unlikely.

First aid facilities No information provided.

4.2 Most important symptoms and effects, both acute and delayed

In high concentrations may cause asphyxiation. Symptoms may include loss of mobility / consciousness. Victim may not be aware of asphyxiation. Inhalation of high levels of hydrogen sulphide may be fatal. Chronic exposure may result in nerve paralysis/damage, heart damage and neurological effects.

4.3 Immediate medical attention and special treatment needed

If inhalation has occurred observe for premonitary signs of pulmonary oedema. Otherwise, treatment is symptomatic and supportive.

5. FIRE FIGHTING MEASURES

5.1 Extinguishing media

Stop flow of gas if safe to do so, such as by slowly closing the cylinder valve. If it is essential to extinguish the flames, use water spray or dry chemical or carbon dioxide extinguisher.

5.2 Special hazards arising from the substance or mixture

Highly flammable gas - potentially explosive. Do not expose to heat or ignition sources. Eliminate ignition sources including cigarettes, open flames, electrical equipment, spark producing switches/ tools, naked lights, heaters, pilot lights, etc when handling.

5.3 Advice for firefighters

Temperatures in a fire may cause cylinders to rupture. Cool cylinders exposed to fire by applying water from a protected location. Do not approach cylinders suspected of being hot. Remove cool cylinders from the path of the fire. Evacuate the area if unable to keep cylinders cool.

6. ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

If the cylinder is leaking, evacuate area of personnel. Inform manufacturer/supplier of leak. Wear self-contained breathing apparatus when entering area unless atmosphere is proved to be safe. Ensure adequate air ventilation. Eliminate all sources of ignition. Consider the risk of potentially explosive atmospheres.

6.2 Environmental precautions

Prevent from entering sewers, basements and workpits, or any place where its accumulation can be dangerous.

6.3 Methods of cleaning up

Carefully move material to a well ventilated remote area, then allow to discharge if safe to do so. Do not attempt to repair leaking valve or cylinder safety devices.

6.4 Reference to other sections

7. HANDLING AND STORAGE

7.1 Precautions for safe handling

Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Do not drag, drop, slide or roll cylinders. The uncontrolled release of a gas under pressure may cause physical harm. Use a suitable hand truck for cylinder movement.

7.2 Conditions for safe storage, including any incompatibilities

Do not store near incompatible substances and sources of ignition. Replace outlet seals after use. Cylinders should be stored: upright, prevented from falling, in a secure area; below 45°C, in a dry, well ventilated area constructed of non-combustible material with firm level floor (preferably concrete), away from areas of heavy traffic and emergency exits.
