SECTION 3 — COMPOSITION/INFORMATION

Emergency Overview: Product is extremely flammable. Pressurized container may explode when exposed to heat or flame. Contact may cause skin and eye irritation. Mist may cause nose and throat irritation. Ingestion may cause nausea, vomiting, pain, upset stomach, and diarrhea.

Potential Health Effects

Skin Contact: This product may cause irritation to the skin. Prolonged or repeated contact with this product may dry and/or defat the skin. This product may be harmful if it is absorbed through the skin.

SECTION 5 — FIRE FIGHTING MEASURES
