4. First Aid Measures

5. Fire-Fighting Measures

6. Accidental Release Measures: Spills may be picked up with a mop and followed by a water rinse. Small spills may be flushed to a sanitary sewer with copious amounts of water.

7. Handling and Storage

7.1 Handling: This product will withstand an occasional accidental freezing without loss in normal performance characteristics. It must be thoroughly thawed and agitated (roll drum) before being used.

7.2 Storage: Store closed container in a cool area away from heat and flame.

8. Exposure Control/Personal Protection

8.1 Occupational Exposure Limits

Monoethanolamine: ACGIH TLV and OSHA PEL= 3ppm; MAK = 5 mg/m³

11. Toxicological Information

11.1 Acute (Primary Routes of Exposure)

Eves: Concentrate is corrosive to tissues. Use dilution may cause significant irritation

Skin: Concentrate is corrosive to tissues. Use dilution may cause slight irritation. Dermal LD₅₀ (rabbits) is

830mg/kg.

Inhalation: Rats exposed to 63.7mg/liter of a 1:256 dilution for six hours showed no toxic effects. Finely divided spray mists of use-dilution irritating to mucous membranes.

Ingestion: Oral LD 50 (rats) 1420mg/kg. Concentrate corrosive to mouth and throat.

11.2 Long Term Exposure: None known.

Carcinogenicity: IARC, NTP and OSHA do not list this product or its ingredients as carcinogens.
