SECTION 6 — ACCIDENTAL RELEASE MEASURES

Personal precautions: No action shall be taken involving any personal risk or without suitable training.

Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapour or mist. Provide adequate ventilation. SECTION 7 — HANDLING AND STORAGE INFORMATION

Handling: Put on appropriate personal protective equipment (see section 8). Eating, drinking
