5. FIRE FIGHTING MEASURES

Fire and explosion Temperatures in a fire may cause cylinders to rupture. Cool cylinders or containers exposed to fire by

applying water from a protected location. Remove cool cylinders from the path of the fire. Evacuate the area if unable to keep cylinders cool. Do not approach cylinders or containers suspected of being

hot.

7. STORAGE AND HANDLING

Storage Do not store near incompatible materials. Cylinders should be stored below 45°C in a secure area,

upright and restrained to prevent cylinders from falling. Cylinders should also be stored in a dry, well ventilated area constructed of non-combustible material with firm level floor (preferably concrete),

away from areas of heavy traffic and emergency exits.

Handling Use of safe work practices are recommended to avoid inhalation. Do not drag, drop, slide or roll

cylinders. The uncontrolled release of a gas under pressure may cause physical harm. Use a

suitable hand truck for cylinder movement.

Chemical stability Stable under recommended conditions of storage. Conditions to avoid Avoid contact with incompatible substances.

Material to avoid Moist carbon dioxide is corrosive, hence acid resistant materials are required (stainless steel).

Certain properties of some plastics and rubbers may be affected by carbon dioxide, ie. embrittlement, leaching of plasticisers, etc. Oil and grease can spontaneously ignite at low temperatures in oxygen enriched atmospheres. Materials which burn in air, will burn more vigorously in oxygen enriched atmospheres. All non-metals must be oxygen compatible. copper is the most

commonly used metal.

11. TOXICOLOGICAL INFORMATION

Health Hazard Asphyxiant gas - non irritant. When released into air the concentration of carbon dioxide is diluted. Carbon dioxide concentrations of 3-5 % in air cause increased respiration and headache. **Summary**

Concentrations of 8-15% cause headache, nausea and vomiting which may lead to unconsciousness if not moved to open air and given oxygen. Inhalation of a mixture containing no oxygen may result in unconsciousness from the first breath and death may follow in minutes. Adverse health affects to long term exposure to carbon dioxide have not been reported. However, in environments such as submarines where exposure to levels of 0.5-1.0% may occur, specialist medical opinion should be

sought on the effects of long term exposure.

Eye

Asphyxiant. Effects are proportional to oxygen displacement. Acts as a simple asphyxiant by Inhalation

displacing oxygen in the lungs thereby diminishing the supply of oxygen to the blood and tissues.

Skin

Ingestion is considered unlikely due to product form. Ingestion
