4. FIRST AID MEASURES

Eye Cold burns: Immediately flush with tepid water or with sterile saline solution. Hold eyelids apart and irrigate for 15

minutes. Seek medical attention.

Inhalation If inhaled, remove from contaminated area. To protect rescuer, use an Air-line respirator or Self Contained

Breathing Apparatus (SCBA). Be aware of possible explosive atmospheres. Apply artificial respiration if not breathing. Give oxygen if available. For advice, contact a Poisons Information Centre on 13 11 26 (Australia Wide)

or a doctor.

Skin Cold burns: Remove contaminated clothing and gently flush affected areas with warm water (30°C) for 15 minutes.

Apply sterile dressing and treat as for a thermal burn. For large burns, immerse in warm water for 15 minutes. DO

NOT apply any form of direct heat. Seek immediate medical attention.

Ingestion Due to product form and application, ingestion is considered unlikely.

5. FIRE FIGHTING MEASURES

Flammability Non flammable. May evolve toxic gases (carbon oxides, hydrogen fluoride, hydrocarbons) when heated strongly.

Fire and Temperatures in a fire may cause cylinders to rupture. Cool cylinders or containers exposed to fire by applying

Explosion water from a protected location. Do not approach cylinders or containers suspected of being hot.

Extinguishing Use water fog to cool containers from protected area.

6. ACCIDENTAL RELEASE MEASURES

Spillage If the cylinder is leaking, evacuate area of personnel. Inform manufacturer/supplier of leak. Use personal protective equipment. Carefully move material to a well ventilated remote area, then allow to discharge. Do not

attempt to repair leaking valve or cylinder safety devices.

7. STORAGE AND HANDLING

Storage Do not store near incompatible materials. Cylinders should be stored below 45°C in a secure area, upright and

restrained to prevent cylinders from falling. Cylinders should also be stored in a dry, well ventilated area constructed of non-combustible material with firm level floor (preferably concrete), away from areas of heavy traffic

and emergency exits.

Handling Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Do not drag, drop, slide

or roll cylinders. The uncontrolled release of a gas under pressure may cause physical harm. Use a suitable hand

truck for cylinder movement.

10. STABILITY AND REACTIVITY

Chemical Stability Stable under recommended conditions of storage.

Conditions to Avoid Avoid heat, sparks, open flames and other ignition sources.

Material to Avoid Incompatible with oxidising agents (eg. hypochlorites), alkalis alkali earth metals. Compounding

ingredients in natural rubber can be extracted during rapid liquid withdrawal and will swell. Also

incompatible with aluminium (exothermic reaction).

Decomposition May evolve toxic gases if heated to decomposition.

11. TOXICOLOGICAL INFORMATION

Health Hazard Summary

Asphyxiant. Symptoms of exposure are directly related to displacement of oxygen. As the amount of oxygen inhaled is reduced from 21-14% volume, the pulse rate may accelerate and the rate and volume of breathing may increase. The ability to maintain attention and think clearly is diminished, muscular co-ordination is somewhat disturbed. As oxygen decreases from 14-10% volume, judgement becomes faulty, severe injuries may result in no pain. Muscular effort may lead to rapid fatigue. Further reduction to 6% may result in nausea and vomiting. Ability to move may be lost. Permanent brain damage may result even after resuscitation from exposure to this low level of oxygen. Below 6% breathing is in gasps and convulsions may occur. Inhalation of a mixture containing no oxygen may result in unconsciousness from the first breath and death may follow in minutes.

Eye Irritant vapour. Low temperature evaporating liquid can cause cold burns.

Inhalation Asphyxiant. Effects are proportional to oxygen displacement.

Skin Irritating vapour. Direct contact with the liquefied material or escaping compressed gas may cause frost-bite injury.

Ingestion Ingestion is considered unlikely due to product form. However, ingestion may result in discomfort of the gastrointestinal tract from rapid evaporation of liquid and consequent evolution of gas. Some of the effects of

inhalation would be expected.

12. ECOLOGICAL INFORMATION

Environment

Vapour-phase tetrafluoromethane is expected to be degraded very slowly in the ambient atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be >110 years. Fluorocarbons have been shown to have a role in depletion of the stratospheric ozone layer.
