4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

Flammability Highly flammable. Eliminate all ignition sources including cigarettes, open flames, spark producing

switches/tools, heaters, naked lights, pilot lights, mobile phones etc. when handling.

Temperatures in a fire may cause cylinders to rupture and internal pressure relief devices to be Fire and Explosion activated. Cool cylinders or containers exposed to fire by applying water from a protected location.

Do not approach cylinders or containers suspected of being hot. This material is capable of forming

explosive mixtures in air.

Extinguishing Stop flow of gas if safe to do so, such as by slowly closing the cylinder valve.

6. ACCIDENTAL RELEASE MEASURES

Spillage

If the cylinder is leaking, eliminate all potential ignition sources and evacuate area of personnel. Prevent spreading of vapours through drains and ventilation systems. Inform manufacturer/supplier of leak. Use personal protective equipment. Carefully move material to a well ventilated remote area, then allow to discharge. Do not attempt to repair leaking valve or cylinder safety devices.

7. STORAGE AND HANDLING

Do not store near sources of ignition or incompatible materials. Cylinders should be stored below Storage

45°C in a secure area, upright and restrained to prevent cylinders from falling. Cylinders should also be stored in a dry, well ventilated area constructed of non-combustible material with firm level floor

(preferably concrete), away from areas of heavy traffic and emergency exits.

Use of safe work practices are recommended to avoid inhalation. Do not drag, drop, slide or roll Handling

cylinders. The uncontrolled release of a gas under pressure may cause physical harm. Use a

suitable hand truck for cylinder movement.

Chronic exposure to carbon monoxide may result in an increase in cardiovascular problems. Can aggravate some diseases of the cardiovascular system such as coronary artery disease. Adverse behavioural effects have been noted including impairment of vigilance, co-ordination, timing, behaviour, visual perception and certain cognitive functions. Some adaptation occurs in individuals repeatedly exposed to moderate concentrations. Developmental defects on foetuses can occur without maternal symptoms. Carbon dioxide is the body's regulator of the breathing function. It is normally present in the air at a concentration of 340 ppm by volume. An increase above this level may result in accelerated breathing and heart rate. Adverse health affects of long term exposure to carbon dioxide have not been reported. However, in environments such as submarines where exposure to levels of 0.5-1.0% may occur, specialist medical opinion should be sought on the effects of long term exposure.

Inhalation Toxic. Over exposure to carbon monoxide may result in rapid breathing, nausea, lack of coordination,

unconsciousness and coma. Carbon monoxide reacts with haemoglobin in the blood to prevent

oxygen uptake and release.
