: **Distillates (petroleum), hydrotreated light**: Mineral spirits have produced slight to moderate skin irritation particularly with evaporation from the skin is prevented. Animal studies have demonstrated that mineral spirits produced mild respiratory tract irritation at elevated concentrations.

Distillates (petroleum), hydrotreated heavy paraffinic: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia.
