<b>Extinguishing media:</b>	Use foam, dry chemical, or water spray to extinguish fire.
<b>Special firefighting procedures:</b>	As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear. Use water spray to cool fire exposed surfaces and to protect personnel.

<b>Spill control procedures (land):</b>	Eliminate sources of ignition. Prevent additional discharge of material, if possible to do so without hazard. For small spills implement cleanup procedures; for large spills implement cleanup procedures and, if in public area, keep public away and advise authorities. Also, if this product is subject to CERCLA reporting (Section 15) notify the National Response Center. Prevent liquid from entering sewers, watercourses, or low areas.
