Methods for Containment and Clean-up:

Stop leak if you can do it without risk.

Absorb or cover with dry earth, sand or other non-combustible material and

transfer to containers.

Use clean non-sparking tools to collect absorbed material. A vapor suppressing foam may be used to reduce vapors.

All equipment used when handling the product must be grounded.

LARGE SPILLS: Water spray may reduce vapor; but may not prevent ignition in

closed spaces.

LARGE SPILLS: Dike far ahead of spill for later disposal.

Section 7: Handling and Storage

Precautions for Safe Handling:

Use only with adequate ventilation. Keep away from heat, sparks, and flame. All equipment used when handling the product must be grounded. Dissipate static electricity during transfer by grounding and bonding containers and equipment before transferring material. Wear appropriate personal protective equipment, avoid direct contact.
