SECTION 4. FIRST AID MEASURES

- Environmental precautions : Do not allow contact with soil, surface or ground water.

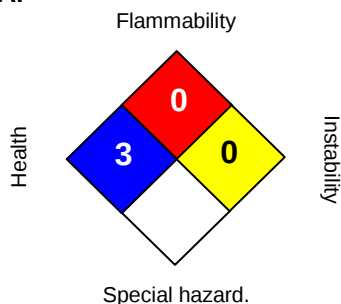
