4. First-aid measures

Conditions for safe storage, including any incompatibilities	Store tightly closed and in properly labelled container in a dry, cool and well ventilated place. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Keep away from direct sunlight and heat. Store away from incompatible materials (see section 10). Keep off freezing.

Eye	If risk of contact with eyes wear chemical splash goggles. Depending on conditions of use, a face shield may be necessary.
Hands	Wear nitrile or neoprene gloves. Disposable nitrile gloves can also be used, but discard after single use. Before using, user should confirm impermeability. Discard gloves that show tears, pinholes, or signs of wear. Gloves must only be worn on clean hands. Wash gloves with water before removing them.
