# 2. COMPOSITION/INFORMATION ON INGREDIENTS:

COMPOSITION COMMENTS: Contains Zinc carbonate (99.9%) coloured with Iron (III) oxide.

# 3. HAZARDS IDENTIFICATION:

## 4. FIRST AID MEASURES:
