EMERGENCY OVERVIEW

IMMEDIATE CONCERNS: DANGER! Highly flammable liquid and vapor. Harmful or fatal if swallowed. Vapor harmful. May cause central nervous system depression. May be irritating to eyes, skin, nose, throat and respiratory tract.

POTENTIAL HEALTH EFFECTS

EYES: Moderately irritating to the eyes.

SKIN: Mildly irritating to the skin.

INGESTION: Irritating to the gastrointestinal tract, causing abdominal pain and vomiting, sometimes bloody. Ingestion may cause CNS depression, low blood pressure, rapid heart beat and liver damage.

INHALATION: May cause mild irritation to the nose, throat and respiratory tract and may result in central nervous system (CNS) depression.

4. FIRST AID MEASURES

EYES: Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention, if irritation occurs or persists.

SKIN: Flush skin with water while removing contaminated clothing. If irritation occurs, get medical attention. Do not reuse clothing or shoes until cleaned.

INGESTION: Do not give liquids if victim is unconscious or drowsy. Otherwise, give 2 glasses of water and induce vomiting by giving 30cc syrup of ipecac (or touching finger to the back of victim's throat). Keep victim's head below hips while vomiting. Call doctor.

INHALATION: Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, oxygen should be administered by qualified personnel. Seek immediate medical attention.

SIGNS AND SYMPTOMS OF OVEREXPOSURE

ACUTE EFFECTS: Irritation as noted above. Early to moderate CNS depression may be evidenced by giddiness, headache, dizziness, and nausea; in extreme cases, unconsciousness and death may occur. Aspiration pneumonitis may be evidenced by coughing, labored breathing and cyanosis (bluish skin). Liver damage may be evidenced by loss of appetite, jaundice and sometimes pain in the upper abdomen on the right side.

5. FIRE FIGHTING MEASURES

FLAMMABLE CLASS: Class IB flammable liquid.

Notes: Acetone has the lowest flash point of any of the constituents at -4 deg F, Heptane next at 15 deg F, then Toluene at 43 deg F, Methanol next at 51 deg F, and finally IPA at 53 deg F. The largest percentage of product is Heptane and combined with acetone have the largest impact on the flash point. While the flash point will be between -4 deg F and 53 deg F, it will be much closer to the lower temperature than the higher.
