2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

IMMEDIATE CONCERNS: WARNING! Flammable liquid and vapor. Harmful or fatal if swallowed. Vapor harmful. May be irritating to eyes and respiratory tract. May cause central nervous system depression.

POTENTIAL HEALTH EFFECTS

EYES: Liquid is moderately irritating to the eyes. High vapor concentrations may also be irritating. Direct contact with the liquid or exposure to its vapors or mists may cause stinging, tearing, redness.

SKIN: Liquid is mildly irritating to the skin. Prolonged or repeated contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

4. FIRST AID MEASURES

EYES: Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention.

5. FIRE FIGHTING MEASURES

FLASHPOINT AND METHOD: 7°C (46.6°F) Lowest flash of chemical constituents within product.

FLAMMABLE LIMITS: 1.5% to 11.4%

AUTOIGNITION TEMPERATURE: Not Determined

EXTINGUISHING MEDIA: Use water fog, "alcohol" foam, dry chemical, or CO2.

HAZARDOUS COMBUSTION PRODUCTS: Carbon monoxide, carbon dioxide and unidentified organic compounds may be formed during combustion.

EXPLOSION HAZARDS: When heated above the flash point, this material emits flammable vapors which, when mixed with air, can burn or be explosive. Fine mists or sprays may be flammable at temperatures below the flash point.

6. ACCIDENTAL RELEASE MEASURES

LARGE SPILL: Remove all sources of ignition and provide ventilation. Handling equipment must be grounded to prevent sparking. Evacuate the hazard area of unprotected personnel. Wear appropriate respirator and protective clothing as given in Section 8. Stop source of leak only if safe to do so. Dike and contain. If vapor cloud forms, water fog may be used to suppress. Contain run-off. Remove with vacuum truck or pump to storage/salvage vessels. Absorb residue or small spills with inert material (clay, sand). Place in non-leaking containers for proper disposal. Flush area with water to remove trace residue. Dispose of flush solutions as above. Prevent contamination of surface waters.

GENERAL PROCEDURES: WARNING. Flammable. Ventilate area of leak or spill. Remove all sources of ignition. Clean-up personnel require protective clothing and respiratory protection from vapors. Only specially trained or qualified personnel should handle the emergency.

7. HANDLING AND STORAGE

GENERAL PROCEDURES: Keep away from heat, sparks, and flame. Surfaces that are hot may ignite even liquid product in the absence of sparks or flame. Extinguish pilot lights, cigarettes and turn off other sources of ignition prior to use and until all vapors are gone.

HANDLING: Avoid contact with skin and eyes. Do not inhale vapors. Keep away from heat and open flame. Wash thoroughly with soap and water after handling. Store tightly closed containers in cool, dry place. Use inert gas blanket.

STORAGE: Keep away from heat, sparks, and flame. Keep away from sources of ignition. Store in a cool, dry, well-ventilated area away from incompatible substances. Flammables-area.
