## 2. HAZARDS IDENTIFICATION

### EMERGENCY OVERVIEW

**IMMEDIATE CONCERNS:** WARNING! Flammable liquid and vapor. Harmful or fatal if swallowed. Vapor harmful. May cause central nervous system depression. May be irritating to eyes and skin.

## POTENTIAL HEALTH EFFECTS

**EYES:** Liquid is moderately irritating to the eyes. High vapor concentrations may also be irritating. Direct contact with the liquid or exposure to its vapors or mists may cause stinging, tearing, redness, swelling and eye damage.

## 4. FIRST AID MEASURES

**EYES:** Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention, if irritation occurs or persists.

## 5. FIRE FIGHTING MEASURES

**FLASHPOINT AND METHOD:** (55°F) Lowest flash of chemical constituents within product.

FLAMMABLE LIMITS: 0.033 to 0.19

**AUTOIGNITION TEMPERATURE:** (685°F)

**EXTINGUISHING MEDIA:** Use "alcohol resistant" foam, dry chemical, or CO2. Water may be ineffective, but water applied as a spray can absorb some of the fire's heat and should be used to keep fire-exposed containers cool.

**HAZARDOUS COMBUSTION PRODUCTS:** Carbon monoxide and unidentified organic compounds may be formed during combustion.

**EXPLOSION HAZARDS:** When heated above the flash point, this material emits flammable vapors which, when mixed with air, can burn or be explosive. Fine mists or sprays may be flammable at temperatures below the flash point.
