3. HAZARDOUS IDENTIFICATION

Other species, including man, were much less sensitive to hemolysis. The hemolytic effect seen in rats was transitory and/or reversible and not considered to be relevant to human health. Inhalation exposure of pregnant rabbits caused some lethality to the dam and fetus at 200 ppm, but there were no effects at 100 ppm and below. Inhalation exposure to pregnant rats caused irritancy to the dams and related fetotoxicity at 200 ppm and 100 pm, but there were no effects at 50 ppm

and below. 2-BE did not cause birth defects in either study.
