4. First-aid measures**Inhalation**

6. Accidental release measures

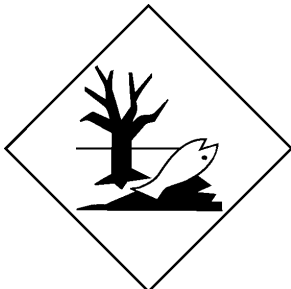
