4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin contact: If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a Doctor; or for 15 minutes and transport to Doctor or Hospital.

Eye contact: Immediately irrigate with copious quantities of water for 15 minutes. Eyelids to be held open. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport to hospital or medical centre.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

10. STABILITY AND REACTIVITY

Reactivity: No reactivity hazards are known for the material.

Chemical stability: This material is thermally stable when stored and used as directed.

Hazardous reactions: Decomposes with loss of water at 580°C to form calcium oxide (quicklime). Reacts with acids. Attacks aluminium, lead and brass in the presence of moisture. Absorbs carbon dioxide from the air.

Conditions to avoid: Avoid exposure to moisture. Avoid contact with acids.

Incompatible materials: Incompatible with acids, nitromethane, nitroethane, nitropropane, nitroparaffins and maleic anhydride.

Hazardous decomposition products: Oxides of calcium.
