SECTION 2 - HAZARDS IDENTIFICATION

Other Ingredients: Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Cocamide MEA, Zinc Carbonate, Glycol Distearate, Dimethicone, Fragrance, Cetyl Alcohol, Sodium Xylenesulfonate, Polyquaternium-10, Magnesium Sulfate, Sodium Chloride, Sodium Benzoate, Ammonium Laureth Sulfate, Magnesium Carbonate Hydroxide, Benzyl Alcohol, Melaleuca Alternifolia (Tea Tree) Leaf Oil, Camellia Sinensis Leaf Extract, Methylchloroisothiazolinone, Methylisothiazolinone, Yellow 5, Blue 1.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

SECTION 4 - FIRST AID MEASURES
