### SECTION 3 - COMPOSITION AND INGREDIENTS

The complete ingredient list for the finished product(s) is as follows:

Active Ingredient: Pyrithione Zinc

Inactive Ingredients: Water, Stearyl Alcohol, Cetyl Alcohol, Stearamidopropyl Dimethylamine, Dimethicone, Glutamic Acid, Fragrance, Benzyl Alcohol, Citric Acid, Methylchloroisothiazolinone, Methylisothiazolinone.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### SECTION 4 - FIRST AID MEASURES

- **Eye:**

Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.
