SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

SECTION 4 - FIRST AID MEASURES

• Eye:

Following accidental eye exposure, thorough rinsing of the affected area for 15-20 minutes with clean cold water is recommended. If discomfort or irritation persists, contact a physician. If the eyes or face becomes swollen during or following use, consult a physician or emergency room immediately.

• Skin Problem:

Thoroughly rinse with water. Discontinue use of product. If discomfort persists and/or the skin reaction worsens, contact a physician immediately. • Inhalation:

- Extinguishing Media: Use chemical foam, dry chemical, carbon dioxide or water.
- **Explosion Hazard:** No applicable information has been found.
- **Fire Fighting Instructions:** Contact emergency personnel. Flammable material. Explosive mixtures may form with air. Use self-contained breathing apparatus and full protective gear, if large quantities of product are involved. Hazardous decomposition products may be released. Thermal degradation may produce oxides of carbon and/or nitrogen; hydrocarbons and/or derivatives. • Procedures for Spill/Leak Clean-up:

• Conditions for Safe Storage:
