It is suspected that tumors may be due in part to severely irritated conditions from continuous contact with the product. Limited studies on oils that are very active carcinogens have shown washing the animals' skin with soap and water between applications greatly decreases the incidence of tumors. In light of these studies, good personal hygiene is essential with the use of this product.
