## Section 4. First aid measures

## Section 5. Fire-fighting measures

### Extinguishing media

**Suitable extinguishing media** : Use dry chemical powder.

**Unsuitable extinguishing media** : Avoid high pressure media which could cause the formation of a potentially explosive dust-air mixture.

**Specific hazards arising from the chemical** : Fine dust clouds may form explosive mixtures with air. This material is toxic to aquatic life with long lasting effects. Fire water contaminated with this material must be contained and prevented from being discharged to any waterway, sewer or drain.

### Personal precautions, protective equipment and emergency procedures

## Section 7. Handling and storage

### Precautions for safe handling

#### Protective measures

- : Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing dust. Avoid the creation of dust when handling and avoid all possible sources of ignition (spark or flame). Prevent dust accumulation. Use only with adequate ventilation.
