3. HAZARDS IDENTIFICATION

Potential Health Effects

May cause mild eye irritation. Symptoms include stinging, tearing, and redness.

Swallowing:

Inhalation:

Absorb liquid on vermiculite, floor absorbent or other absorbent material.

Large Spill:

Eliminate all ignition sources (flares, flames including pilot lights, electrical sparks). 7. HANDLING AND STORAGE

Handling:
