SECTION 2 HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

SECTION 7 HANDLING AND STORAGE

Precautionary Measures: Do not get in eyes, on skin, or on clothing. Do not breathe oil mist at concentrations above the recommended mineral oil mist exposure limit.
