4. First aid measures

Eye contact

Protection of first-aiders

: No action shall be taken involving any personal risk or without suitable training. 5. Fire-fighting measures

6. Accidental release measures

Personal precautions

Environmental precautions

Methods for cleaning up

Small spill

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). 7. Handling and storage

Handling

: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Do not get in eyes or on skin or clothing. 8. Exposure controls/personal protection

Recommended monitoring procedures
