SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

POTENTIAL HEALTH EFFECTS:

Mineral Oil, Kaolin, Mica, Titanium Dioxide, Nylon-12, Carnauba Wax, Beeswax, Paraffin, Ozokerite, Methylparaben, Propylparaben, Sorbic Acid, Iron Oxides, Carmine, Red 7 Lake, Ultramarines, Red 6 Lake, Yellow 5 Lake.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.
