# **SECTION 6: Accidental release measures**

### 6.1. Personal precautions, protective equipment and emergency procedures

#### 8.2. Exposure controls

### 8.2.1. Engineering controls

Provide ventilated enclosure for heat curing. Curing enclosures must be exhausted to outdoors or to a suitable emission control device. Do not remain in area where available oxygen may be reduced.
