#### CONCENTRATE

- The Product contains Sodium Alkyl Sulphate in aqueous medium. The ingredients are not volatile therefore airborne exposure limits are not relevant.
- When using the concentrate keep containers closed when not in use. Avoid skin and eye contact.
- There are no specific handling requirements however it has been reported in toxicological literature that long term occupational skin exposure may cause eczema/dermatitis. It is therefore recommended that appropriate gloves be used when handling the product.
