Section 5. Fire-fighting measures

Extinguishing media

Suitable extinguishing media : Use an extinguishing agent suitable for the surrounding fire.

Specific hazards arising from the chemical : In a fire or if heated, a pressure increase will occur and the container may burst. Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Methods and materials for containment and cleaning up

Precautions for safe handling
