Inactive Ingredients: Water, Sodium Lauroamphoacetate, Sodium Myristoyl Sarcosinate, Sodium Trideceth Sulfate, Sorbitol, Glycerin, PEG-120 Methyl Glucose Dioleate, Citric Acid, Fragrance, PEG-100, Disodium EDTA, BHT, Panthenol, Methylchloroisothiazolinone, Methylisothiazolinone, Salvia Officinalis (Sage) Leaf Extract, Aloe Barbadensis Leaf Juice, Camellia Sinensis Leaf Extract, Sodium Dehydroacetate.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

SECTION 4 - FIRST AID MEASURES

- **Eye:**
