### **SECTION 2 - HAZARDS IDENTIFICATION**

### **EMERGENCY OVERVIEW:**

### **POTENTIAL HEALTH EFFECTS:**

### • Eye:

Contact may cause mild, transient irritation. Some redness and/or stinging may occur.

## SECTION 3 - COMPOSITION AND INGREDIENTS

Active Ingredient: Salicylic Acid

Inactive Ingredients: Water, SD Alcohol 40-B, Sodium Dehydroacetate, Aloe Barbadensis Leaf Juice, Salvia Officinalis (Sage) Leaf Extract, Camellia Sinensis Leaf Extract, Panthenol, Fragrance, Isoceteth-20, Disodium EDTA, Red 33, Green 5.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### **SECTION 4 - FIRST AID MEASURES**

#### • Eye:

Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.
