**Other Ingredients:** Water, Glycerin, Polyethylene, Dimethicone, Niacinamide, Pentylene Glycol, Panthenol, Tocopheryl Acetate, Isohexadecane, Polysorbate 60, Dimethiconol, PEG-4 Laurate, PEG-4 Dilaurate, Iodopropynyl Butylcarbamate, PEG-4, Stearic Acid, Cetearyl Glucoside, Hydroxyethyl Acrylate/Sodium Acryloyldimethyl Taurate Copolymer, Cetearyl Alcohol, Ascorbic Acid, Benzyl Alcohol, Cetyl Alcohol, Stearyl Alcohol, Behenyl Alcohol, Methylparaben, Ethylparaben, Propylparaben, Disodium EDTA, PEG-100 Stearate, Fragrance.
