Water, Cyclopentasiloxane, Glycerin, Niacinamide, Polyethylene, Acetyl Glucosamine, Dimethicone, Polyacrylamide, Dimethicone Crosspolymer, Panthenol, Triethanolamine, C13-14 Isoparaffin, Acrylates/C10-30 Alkyl Acrylate Crosspolymer, Dimethiconol, DMDM Hydantoin, Tocopheryl Acetate, Laureth-4, Soluble Collagen, Ascorbyl Glucoside, Disodium EDTA, Aloe Barbadensis Leaf Juice, Laureth-7, Hedychium Coronarium Root Extract, Butylene Glycol, Iodopropynyl Butylcarbamate, Phenoxyethanol, Fragrance, Titanium Dioxide, Mica.

### SECTION 4 - FIRST AID MEASURES
