Water, Sodium Laureth Sulfate, Sodium Sulfate, Cocamidopropyl Betaine, Fragrance, Sodium Lauroamphoacetate, Citric Acid, Sodium Benzoate, Polyquaternium-10, Disodium EDTA, Methylchloroisothiazolinone, Methylisothiazolinone, Red 33, Orange 4.
