Water, Petrolatum, Mineral Oil, Sodium Trideceth Sulfate, Sodium Lauryl Sulfate, Sodium Lauroamphoacetate, Sodium Chloride, Fragrance, Trideceth-3, Simmondsia Chinensis (Jojoba) Butter, Orchis Morio Flower Extract, Citric Acid, Guar Hydroxypropyltrimonium Chloride, Acrylonitrile/Methacrylonitrile/Methyl Methacrylate Copolymer, Isopentane, Xanthan Gum, Sodium Benzoate, Disodium EDTA, PEG-90M, Methylchloroisothiazolinone, Methylisothiazolinone, Sodium Hydroxide, Violet 2.
