SECTION 2 - HAZARDS IDENTIFICATION
EMERGENCY OVERVIEW: This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.
POTENTIAL HEALTH EFFECTS:

Water, Glycerin, Stearic Acid, Caprylic/Capric Triglyceride, Cetyl Alcohol, Glycol Distearate, PEG-8, Tocopheryl Acetate, Cetearyl Alcohol, Cetareth-20, Cocamide MEA, Ricinus Communis (Castor) Seed Oil, Triethanolamine, DMDM Hydantoin, Iodopropynyl Butylcarbamate, Carbomer, Fragrance, Disodium EDTA, PEG-10 Soy Sterol.

SECTION 4 - FIRST AID MEASURES
