SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

POTENTIAL HEALTH EFFECTS:

- **Eye:** Contact may cause mild, transient irritation. Some redness and/or stinging may occur.

Inactive Ingredients: Water, Glycerin, Polyethylene, Dimethicone, Isopropyl Isostearate, Pentyleneglycol, Panthenol, Triethanolamine, Tocopheryl Acetate, Sodium Dehydroacetate, Stearyl Alcohol, Behenyl Alcohol, Cetyl Alcohol, Hydroxyethylcellulose, Dimethiconol, PEG-100 Stearate, Cetearyl Glucoside, Cetearyl Alcohol, Acrylates/C10-30 Alkyl Acrylate Crosspolymer, Disodium EDTA, Carbomer, Iodopropynyl Butylcarbamate, Benzyl Alcohol, Methylparaben, Ethylparaben, Propylparaben.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

SECTION 4 - FIRST AID MEASURES
