### SECTION 3 - COMPOSITION AND INGREDIENTS

Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Sodium Chloride, Fragrance, Cocamidopropyl Betaine, Citric Acid, Sodium Benzoate, Disodium EDTA, Methylchloroisothiazolinone, Methylisothiazolinone, Green 3, Red 33.
