Section 5. Fire-fighting measures

Extinguishing media

- Specific hazards arising from the chemical** : Flammable liquid and vapor. Methods and materials for containment and cleaning up

Precautions for safe handling

Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation.
