4. FIRST AID MEASURES

SMALL SPILLS: Sweep up, but avoid generating dust. Collect and seal in properly labelled containers for disposal or re-use.

LARGE SPILLS: Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

7. HANDLING AND STORAGE

Conditions for safe storage:

Keep containers sealed as material may absorb moisture. Keep containers closed when not in use - check regularly for spills.

Precautions for safe handling:

Avoid skin and eye contact and breathing in dust.
