## 4. FIRST AID MEASURES

## 5. FIRE-FIGHTING MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Wear protective equipment to prevent skin and eye contamination. Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

### LARGE SPILLS

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Contain – prevent run off into drains and waterways. Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact and inhalation of vapour.

**Personal protection equipment:** GREEN: OVERALLS, SAFETY SHOES, SAFETY GLASSES, GLOVES.
