Water, Galactomyces Ferment Filtrate, Glycerin, Niacinamide, Butylene Glycol, Pentylene Glycol, Diphenylsiloxy Phenyl Trimethicone, Glycereth-25 PCA Isostearate, Dipotassium Glycyrrhizate, Ascorbyl Glucoside, Centella Asiatica Extract, Nylon-12, Sodium Hyaluronate, Saccharomyces Cerevisiae Extract, Acrylates/C10-30 Alkyl Acrylate Crosspolymer, Aminomethyl Propanol, Disodium EDTA, Xanthan Gum, Benzyl Alcohol, Sodium Benzoate, Phenoxyethanol, Methylparaben, Fragrance.
