<b>SECTION 2 - HAZARDS IDENTIFICATION</b>

Water, Saccharomycopsis Ferment Filtrate, Butylene Glycol, Polysorbate 20, Glycerin, Sodium Hyaluronate, Salicylic Acid, Lactic Acid, Malic Acid, PEG-150, Cellulose Gum, Sodium Benzoate, Methylparaben, Disodium EDTA, Citric Acid, Sodium Citrate.
