SECTION 2 - HAZARDS IDENTIFICATION

Active Ingredient: Triclosan

Inactive Ingredients: Water, Sodium Lauryl Sulfate, Sodium Laureth Sulfate, Lauramide DEA, Glycol Distearate, Cocamidopropyl Betaine, Sodium Sulfate, Fragrance, Guar Hydroxypropyltrimonium Chloride, Citric Acid, DMDM Hydantoin, Tetrasodium EDTA, Red 4, Yellow 5.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

SECTION 4 - FIRST AID MEASURES

- **Eye:**

Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.
