## 5. FIRE FIGHTING MEASURES

### **Suitable Extinguishing Media:**

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

### **Specific hazards arising from the substance or mixture:**

Not combustible, however following evaporation of the water component of the material, the residual material can burn if ignited. On burning will emit toxic fumes, including those of oxides of carbon .

### **Special protective equipment and precautions for fire-fighters:**

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

## 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures/Environmental precautions:**

If contamination of sewers or waterways has occurred advise local emergency services.

### **Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:**

SMALL SPILLS: Slippery when spilt. Avoid accidents, clean up immediately. Wipe up with rag or absorbent paper.

LARGE SPILLS: Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

### **Precautions for safe handling:**

Keep out of reach of children. Avoid eye contact and repeated or prolonged skin contact.

### **Conditions for safe storage, including any incompatibilities:**

Store away from incompatible materials described in Section 10. Protect from freezing. Keep containers closed when not in use - check regularly for leaks.

As published by Safe Work Australia Workplace Exposure Standards for Airborne Contaminants.

**TWA** - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.

**STEL** (Short Term Exposure Limit) - the airborne concentration of a particular substance calculated as a time-weighted average over 15 minutes, which should not be exceeded at any time during a normal eight hour work day. According to current knowledge this concentration should neither impair the health of, nor cause undue discomfort to, nearly all workers.

**`Sk'** (skin) Notice - absorption through the skin may be a significant source of exposure. The exposure standard is invalidated if such contact should occur.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

## Appropriate engineering controls:

Natural ventilation should be adequate under normal use conditions. Keep containers closed when not in use.

## Individual protection measures, such as Personal Protective Equipment (PPE):
