### SECTION 4 - FIRST AID MEASURES

- **Eye:**

### SECTION 5 - FIRE FIGHTING MEASURES

- **Extinguishing Media:** Use chemical foam, dry chemical, carbon dioxide or water.
- **Explosion Hazard:** Flammable. Container may rocket or explode in heat of fire. Explosive mixtures may form with air if large quantities of product are released in unventilated areas.
- **Fire Fighting Instructions:** Contact emergency personnel. Contents under pressure. Container may rocket or explode in heat of fire.
