4 . First aid measures

Eye contact

: Check for and remove any contact lenses. Get medical attention if irritation occurs. Immediately flush eyes with running water for at least 30 minutes, keeping eyelids open.

Skin contact

Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Continue to rinse for at least 15 minutes. Get medical attention. May cause sensitization by skin contact. 6. Accidental release measures

Personal precautions

8. Exposure controls/personal protection
