4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. LARGE SPILLS

Clear area of all unprotected personnel. Prevent further leakage or spillage if safe to do so. Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. MANUFACTURING, PACKAGING AND TRANSPORT:
